6. TARGETS:

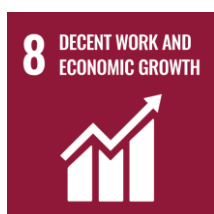
- Educational Workshop: Apexon aim to achieve a 20% increase in attendance at community educational workshops compared to FY 2023.
